1. Aims

This policy aims to show our commitment to meeting our obligations with regards to school attendance, including those laid out in the Department for Education’s (DfE’s) statutory guidance on [working together to improve school attendance \(applies from 19 August 2024\)](#), through our whole-school culture and ethos that values good attendance, including:

- Setting high expectations for the attendance and punctuality of all pupils
- Promoting good attendance and the benefits of good attendance
- Reducing absence, including persistent and severe absence
- Ensuring every pupil has access to the full-time education to which they are entitled
- Acting early to address patterns of absence
- Building strong relationships with families to make sure pupils have the support in place to attend school

We will also promote and support punctuality in attending lessons.

2. Legislation and guidance

3. Roles and responsibilities

3.1 The governing board

The governing board is responsible for:

- Setting high expectations of all school leaders, staff, pupils and parents
- Making sure school leaders fulfil expectations and statutory duties, including:
 - Making sure the school records attendance accurately in the register, and shares the required information with the DfE and local authority
 - Making sure the school works effectively with local partners to help remove barriers to attendance, and keeps them informed regarding specific pupils, where appropriate
- Recognising and promoting the importance of school attendance across the school's policies and ethos
- Making sure the school's attendance management processes are delivered effectively, and that consistent support is provided for pupils who need it most by prioritising staff and resources
- Making sure the school has high aspirations for all pupils, but adapts processes and support to pupils' individual needs
- Regularly reviewing and challenging attendance data and helping school leaders focus improvement efforts on individual pupils or cohorts who need it most
- Working with school leaders to set goals or areas of focus for attendance and providing support and challenge
- Monitoring attendance figures for the whole school and repeatedly evaluating the effectiveness of the school's processes and improvement efforts to make sure they are meeting pupils needs
- Where the school is struggling with attendance, working with school leaders to develop a comprehensive action plan to improve attendance
- Making sure all staff receive adequate training on attendance as part of the regular continued professional development offer, so that staff understand:
 - The importance of good attendance
 - That absence is almost always a symptom of wider issues
 - The school's legal requirements for keeping registers
 - The school's strategies and procedures for tracking, following up on and improving attendance, including working with partners and keeping them informed regarding specific pupils, where appropriate
- Making sure dedicated training is provided to staff with a specific attendance function in their role, including in interpreting and analysing attendance data

- Holding the Executive Headteacher & the Head of School to account for the implementation of this policy

3.2 The Executive Headteacher & the Head of School

The Executive Headteacher (Nicola Price) & the Head of School (Jodie Bailey) are responsible for:

- The implementation of this policy at the school
- Monitoring school-level absence data and reporting it to governors
- Supporting staff with monitoring the attendance of individual pupils
- Monitoring the impact of any implemented attendance strategies
- Issuing fixed-penalty notices, where necessary
- Working with the parents of pupils with special educational needs and/or disabilities (SEND) to develop specific support approaches for attendance for pupils with SEND, including where school transport is regularly being missed, and where pupils with SEND face in-school barriers
- Communicating with the local authority when a pupil with an education, health and care (EHC) plan has falling attendance, or where there are barriers to attendance that relate to the pupil's needs
- Communicating the school's high expectations for attendance and punctuality regularly to pupils and parents through all available channels

3.3 The designated senior leader responsible for attendance

The designated senior leader (Head of School) is responsible for:

- Leading, championing and improving attendance across the school
- Setting a clear vision for improving and maintaining good attendance
- Evaluating and monitoring expectations and processes
- Having a strong grasp of absence data and oversight of absence data analysis
- Regularly monitoring and evaluating progress in attendance
- Establishing and maintaining effective systems for tackling absence, and making sure they are followed by all staff
- Liaising with pupils, parents/carers and external agencies, where needed
- Building close and productive relationships with parents to discuss and tackle attendance issues
- Creating intervention or reintegration plans in partnership with pupils and their parents/carers
- Delivering targeted intervention and support to pupils and families

The designated senior leader responsible for attendance is the Head of School (Jodie Bailey) and can be contacted via calling 01283 216883 or emailing enquiries@elmsleigh.derbyshire.sch.uk.

3.4 The attendance officer

The school attendance officer is responsible for:

- Monitoring and analysing attendance data (see section 7)
- Benchmarking attendance data to identify areas of focus for improvement
- Providing regular attendance reports to school staff and reporting concerns about attendance to the Head of School responsible for attendance, and the Executive Headteacher

- Working with the Pastoral Lead (Tina Arckless) to tackle persistent absence
- Advising the Executive headteacher / Head of School (authorised by the Executive headteacher) when to issue fixed-penalty notices

The attendance officer is Elisha Flamson and can be contacted via calling 01283 216883 or emailing enquiries@elmsleigh.derbyshire.sch.uk.

3.5 Class Teachers

Class teachers are responsible for recording attendance for both morning and afternoon sessions on a daily basis, using the correct codes (see Appendix 1), and submitting this information to the school office and submitting this information to the school office by 9:30am

Class teachers must:

- ❖ Encouraging good attendance through verbal praise and rewards.
- ❖ Ensure that registers are correctly and promptly marked, using correct codes (Appendix 1).
- ❖ Set a good example in matters of attendance and punctuality.
- ❖ Ensure that parents are informed of their child's attendance during parent consultations.
- ❖ Continue to provide a safe and secure environment in which to learn.
- ❖ Provide engaging and worthwhile learning experiences that encourage students to regularly attend lessons.
- ❖ Promote the importance of a good routine and a healthy lifestyle, ie: getting lots of sleep and drinking lots of water.

3.6 School Admin staff

School Admin staff will:

- Take calls from parents/carers about absence on a day-to-day basis and record it on the school system
- Transfer calls from parents/carers to the Pastoral Lead (Tina Arckless) where appropriate, in order to provide them with more detailed support on attendance

3.7 Parents

Where this policy refers to a parent, it refers to the adult the school and/or local authority decides is most appropriate to work with, including:

- All natural parents, whether they are married or not
- All those who have parental responsibility for a child or young person
- Those who have day-to-day responsibility for the child (i.e. lives with and looks after them)

Parents are expected to:

- Make sure their child attends every day and on time
- Contact the school by 8:45am each morning via the absence line (01283 216883, option 1) or email enquiries@elmsleigh.derbyshire.sch.uk Parents must clearly state child's name, class, and reason for absence.
- Provide the school with more than 1 emergency contact number for their child
- Ensure that, where possible, appointments for their child are made outside of the school day
- Keep to any attendance contracts that they make with the school and/or local authority

- Seek support, where necessary, for maintaining good attendance, by contacting the Attendance Officer (Elisha Flamson) or the Pastoral Lead (Tina Arckless) who can be contacted via calling 01283 216883 or emailing enquiries@elmsleigh.derbyshire.sch.uk

3.8 Pupils

Children have a responsibility to themselves and others to play a positive role in the life of Elmsleigh school and to make the most of the education opportunities available. Although our children are very young, this ethos is instilled at the first opportunity in their school years.

Pupils are expected to:

- Attend school every day, on time
- Encourage friendship and a sense of belonging.
- Be happy and encourage others to feel happy.
- Develop resilience engage in learning by using the Zones of regulation to help them
- Understand the importance of a good routine and a healthy lifestyle, ie: getting lots of sleep and drinking lots of water
- Inform a trusted adult if they feel that they are being bullied or feel unhappy in school.

4. Recording attendance

4.1 Attendance register

We will keep an electronic attendance register and place all pupils onto this register.

We will take our attendance register at the start of the first session of each school day and once during the second session. It will mark, using the appropriate national attendance and absence codes from the School Attendance (Pupil Registration) (England) Regulations 2024, whether every pupil is:

- Present
- Attending an approved off-site educational activity
- Absent
- Unable to attend due to exceptional circumstances

Any amendment to the attendance register will include:

- The original entry
- The amended entry
- The reason for the amendment
- The date on which the amendment was made
- The name and position of the person who made the amendment

See Appendix 1 for the DfE attendance codes.

We will also record:

- Whether the absence is authorised or not
- The nature of the activity, where a pupil is attending an approved educational activity
- The nature of circumstances, where a pupil is unable to attend due to exceptional circumstances

We will keep every entry on the attendance register for 6 years after the date on which the entry was made.

The school day starts at **8.45am** and ends at **3.15pm**.

Pupils must arrive in school by **8.45am** on each school day.

The register for the first session will be taken at 8.45am and will be kept open until 9.00am. After 9.00am pupils will be registered as late, after 9.30am pupils will receive an unauthorised late. The register for the afternoon session will be taken at 1.05pm and will be kept open until 1.15pm.

4.2 Unplanned absence

The pupil's parent must notify the school of the reason for the absence on the first day of an unplanned absence by 8.45am or as soon as practically possible, by calling the school **absence line (01283 216883, option 1)** or email the office at enquiries@elmsleigh.derbyshire.sch.uk explaining the reason for the absence.

We will mark absence due to physical or mental illness as authorised, unless the school has a genuine concern about the authenticity of the illness.

Where the absence is longer than 5 days, or there are doubts about the authenticity of the illness, the school will ask for medical evidence, such as a doctor's note, prescription, appointment card or other appropriate form of evidence. We will not ask for medical evidence unnecessarily.

If the school is not satisfied about the authenticity of the illness, the absence will be recorded as unauthorised and parents will be notified of this in advance.

4.3 Planned absence

Attending a medical or dental appointment will be counted as authorised if the pupil's parent/carer notifies the school in advance of the appointment. The office must be notified by emailing enquiries@elmsleigh.derbyshire.sch.uk as soon as the appointment has been booked. Alternatively, parents can send a letter to the school office.

However, we encourage parents to make medical and dental appointments out of school hours where possible. Where this is not possible, the pupil should be out of school for the minimum amount of time necessary.

The pupil's parent must also apply for other types of term-time absence as far in advance as possible of the requested absence. Go to section 5 to find out which term-time absences the school can authorise.

4.4 Lateness and punctuality

A pupil who arrives late:

- Before the register has closed will be marked as late, using the appropriate code
- After the register has closed will be marked as absent, using the appropriate code

Some issues with punctuality will sometimes relate to travel difficulties, so these may need addressing with the taxi company, driver or parents as necessary.

4.5 Following up unexplained absence

Where any pupil we expect to attend school does not attend, or stops attending, without reason, the school will:

- Call the pupil's parent on the morning of the first day of unexplained absence to ascertain the reason. If the school cannot reach any of the pupil's emergency contacts. Where pupils have notable vulnerability factors or safeguarding concerns a home visit or referral to support services may be considered.

- Identify whether the absence is approved or not
- Identify the correct attendance code to use and input it as soon as the reason for absence is ascertained – this will be no later than 5 working days after the session(s) for which the pupil was absent
- Call the parent on each day that the absence continues without explanation, to make sure proper safeguarding action is taken where necessary. If absence continues, the school will consider involving an education welfare officer
- Where appropriate, offer support to the pupil and/or their parents to improve attendance
- Identify whether the pupil needs support from wider partners, as quickly as possible, and make the necessary referrals
- Where support is not appropriate, not successful, or not engaged with the school will pursue a notice to improve, penalty notice or other legal intervention as appropriate (see section 5.2 below).

4.6 Reporting to parents

The school will regularly inform parents (see definition of ‘parent’, as used in this policy, in section 3.7 above) about their child’s attendance and absence levels.

Parents will receive termly reports on their child’s attendance and an annual report summarizing the whole school year. They will be updated on the relative RAG (Red-Amber-Green) rating for their child’s to-date attendance percentages and information on how many days/weeks equivalent and lessons they have missed at that point in the year.

Pupils will be grouped into categories based on their percentage attendance as follows:

GREEN GROUP
93.1% - 100%
WELL DONE - THIS IS EXCELLENT!

AMBER GROUP
90.1% - 93%
LOW ATTENDANCE

RED GROUP
Less than 90%
PERSISTENT ABSENCE PUPIL

The School has a legal duty to publish its absence figures to parent/carers and to promote good attendance. Equally, parent/carers have a duty to make sure that their children attend. School staff are committed to working with parent/carers as the best way to ensure as high a level of attendance as possible.

5. Authorised and unauthorised absence

5.1 Approval for term-time absence

The headteacher will allow pupils to be absent from the school site for certain educational activities, or to attend other schools or settings.

The headteacher will only grant a **leave of absence** to a pupil during term time if the request meets the specific circumstances set out in the [2024 school attendance regulations](#). These circumstances are:

- Taking part in a regulated performance, or regulated employment abroad
- Attending an interview
- Study leave
- A temporary, time-limited part-time timetable
- Exceptional circumstances

A leave of absence is granted at the headteacher's discretion, including the length of time the pupil is authorised to be absent for.

We define 'exceptional circumstances' as *"a situation or circumstance where the pupil's absence cannot be clearly defined using another register code, or where there are limited controls or ability to allow the pupil to attend."*

Leave of absence will not be granted for a pupil to take part in protest activity during school hours.

As a leave of absence will only be granted in exceptional circumstances, it is unlikely a leave of absence will be granted for the purposes of a family holiday.

The school considers each application for term-time absence individually, taking into account the specific facts, circumstances and relevant background context behind the request.

Any request should be submitted as soon as it is anticipated and, where possible, at least 4 weeks/1 month before the absence, and in accordance with any leave of absence request form, accessible via the Head of School / The Attendance Officer. The Head of School may require evidence to support any request for leave of absence.

Other valid reasons for **authorised absence** include (but are not limited to):

- Illness (including mental-health illness) and medical/dental appointments (see sections 4.2 and 4.3 for more detail)
- Religious observance – where the day is exclusively set apart for religious observance by the religious body to which the pupil's parent(s) belong(s). If necessary, the school will seek advice from the parent's religious body to confirm whether the day is set apart
- Parent(s) travelling for occupational purposes – this covers Roma, English and Welsh gypsies, Irish and Scottish travellers, showmen (fairground people) and circus people, bargees (occupational boat dwellers) and new travellers. Absence may be authorised only when a traveller family is known to be travelling for occupational purposes and has agreed this with the school, but it is not known whether the pupil is attending educational provision
- If the pupil is currently suspended or excluded from school (and no alternative provision has been made)

Other reasons the school may allow a pupil to be absent from the school site, which are not classified as absences, include (but are not limited to):

- Attending an offsite approved educational activity, sporting activity or visit or trip arranged by the school
- Attending another school at which the pupil is also registered (dual registration)
- Attending provision arranged by the local authority
- Attending work experience
- If there is any other unavoidable cause for the pupil not to attend school, such as disruption to travel caused by an emergency, a lack of access arrangements, or because the school premises are closed

5.2 Sanctions

Our school will make use of the full range of potential sanctions – including, but not limited to, those listed below – to tackle poor attendance. Decisions will be made on an individual, case-by-case basis.

Penalty notices

The Executive Headteacher / Head of School (or someone authorised by them), local authority or the police can fine parents for the unauthorised absence of their child from school, where the child is of compulsory school age, by issuing a penalty notice.

If the school issues a penalty notice, it will check with the local authority before doing so and send it a copy of any penalty notice issued.

Before issuing a penalty notice, the school will consider the individual case, including:

- Whether the national threshold for considering a penalty notice has been met (10 sessions of unauthorised absence in a rolling period of 10 school weeks)
- Whether a penalty notice is the best available tool to improve attendance for that pupil
- Whether further support, a notice to improve or another legal intervention would be a more appropriate solution
- Whether any obligations that the school has under the Equality Act 2010 make issuing a penalty notice inappropriate

Each parent who is liable for the pupil's offence(s) can be issued with a penalty notice, but this will usually only be the parent/parents who allowed the absence.

The payment must be made directly to the local authority, regardless of who issues the notice. If the payment has not been made after 28 days, the local authority can decide whether to prosecute or withdraw the notice.

If issued with a **first** penalty notice, the parent must pay £80 within 21 days, or £160 within 28 days.

If a **second** penalty notice is issued to the same parent in respect of the same pupil, the parent must pay £160 if paid within 28 days.

A **third** penalty notice cannot be issued to the same parent in respect of the same child within 3 years of the date of the issue of the first penalty notice. In a case where the national threshold is met for a third time within those 3 years, alternative action will be taken instead.

A penalty notice may also be issued where parents allow their child to be present in a public place during school hours without reasonable justification, during the first 5 days of a suspension or exclusion (where the school has notified the parents that the pupil must not be present in a public place on that day). These penalty notices are not included in the National Framework, not subject to the same considerations about support being provided, and do not count towards the limit as part of the escalation process.

In these cases, the parent must pay £60 within 21 days, or £120.

Notices to improve

If the national threshold has been met and support is appropriate, but parents do not engage with offers of support, the school may offer a notice to improve to give parents a final chance to engage with support.

Notices to improve will be issued in line with processes set out in the local code of conduct for the local authority area in which the pupil attends school.

They will include:

- Details of the pupil's attendance record and of the offences
- The benefits of regular attendance and the duty of parents under [section 7 of the Education Act 1996](#)
- Details of the support provided so far
- Opportunities for further support, or to access previously provided support that was not engaged with
- A clear warning that a penalty notice may be issued if attendance doesn't improve within the improvement period, along with details of what sufficient improvement looks like, which will be decided on a case-by-case basis
- A clear timeframe of between 3 and 6 weeks for the improvement period
- The grounds on which a penalty notice may be issued before the end of the improvement period

6. Strategies for promoting attendance

Elmsleigh Infant & Nursery School promotes attendance through a number of means, some are proactive while others are responses to new issues. All contribute to whole school, cohort and individual's attendance rates.

- Whole school attendance improvement action plan with termly reviews, linked to the school development plan. The action plan is based on attendance data analysis, knowledge of trends or concerns and relative safeguarding issues.
- Relationships with parents/carers are valued and essential in improving/maintaining good attendance. The school encourages regular contact and keeping parents informed of behaviour, barriers, celebrations and attendance rates and concerns. Key working and statutory reporting support this. SLT availability is important in parents and careers confidence in reporting difficulties.
- **Elmsleigh Infant & Nursery School** senior leaders support pupils with low attendance rates or concerning trends. A tracker is kept which flags any pupils where attendance is not good enough. For pupils with severe attendance issues bespoke engagement plans can be drawn up and agreed with families and related services.
- Communication of High expectations – consistent reiteration of attendance expectations to pupils, parents/carers, staff and other stakeholders is essential. This is not only part of the school's ethos and culture on a day-to-day basis, but also through consistent communication of successes and concerns.
- Rewards and celebrations. Good attendance is rewarded as are improved attendance rates. Successes are celebrated in assemblies and through home-school liaison.
- All staff receive CPD which links to attendance and safeguarding.

- **Elmsleigh Infant & Nursery School** seeks to work alongside Local Authority and stakeholders around attendance and related safeguarding initiatives.
- The school's strategies include targeted support meetings which follow initial steps plus an attendance meeting. These support meetings seek to offer support and strategies based on the individual pupil/family and is empathetic to individual cases and their dynamics.

7. Supporting pupils who are absent or returning to school

7.1 Pupils absent due to complex barriers to attendance

Elmsleigh Infant School is also aware that minor changes in students' lives, transport arrangements, domestic situations, class groupings, peer relationships, medication changes, care placements and services involvement may significantly influence their emotional and mental health. This must be considered in actions taken relating to attendance.

7.2 Pupils absent due to mental or physical ill health or SEND

Each student's attendance and SEND related difficulties will be treated on an individual basis according to need, but will always be equitable and fair. Students of concern are clearly identified and their attendance monitored. Strategies put in place are recorded and reviewed.

Where a pupil has an education health and care (EHC) plan and their attendance falls, or the school becomes aware of barriers to attendance that related to the pupil's needs, the school will inform the local authority.

7.3 Pupils returning to school after a lengthy or unavoidable period of absence

Each student's attendance and SEND related difficulties will be treated on an individual basis according to need. Elmsleigh Infant and Nursery School will support pupils back into school following a lengthy or unavoidable period of absence and provide support to build confidence and bridge gaps.

8. Attendance monitoring

8.1 Monitoring attendance

The school will monitor attendance and absence data (including punctuality) half-termly, termly and yearly across the school and at an individual pupil, year group and cohort level.

Specific pupil information will be shared with the DfE on request.

Data will be collected each term and published at national and local authority level through the DfE's school absence national statistics releases. The underlying school-level absence data is published alongside the national statistics.

The school will benchmark its attendance data at whole school, year group and cohort level against local, regional, and national levels to identify areas of focus for improvement and share this with the governing board.

8.2 Analysing attendance

The school will:

- Analyse attendance and absence data regularly to identify pupils, groups or cohorts that need additional support with their attendance, and
- Identify pupils whose absences may be a cause for concern, especially those who demonstrate patterns of persistent or severe absence
- Conduct thorough analysis of half-termly, termly, and full-year data to identify patterns and trends
- Look at historic and emerging patterns of attendance and absence, and then develop strategies to address these patterns

8.3 Using data to improve attendance

The School will:

- Develop targeted actions to address patterns of absence (of all severities) of individual pupils, groups or cohorts that it has identified via data analysis
- Provide targeted support to the pupils it has identified whose absences may be a cause for concern, especially those who demonstrate patterns of persistent or severed absence, and their families (see section 8.4 below)
- Provide regular attendance reports to Class Teachers to facilitate discussions with pupils and families, and to the governing board and school leaders (including special educational needs co-ordinators, designated safeguarding leads and pupil premium lead)
- Use data to monitor and evaluate the impact of any interventions put in place in order to modify them and inform future strategies
- Share information and work collaboratively with other schools in the area, local authorities and other partners where a pupil's absence is at risk of becoming persistent or severe, including keeping them informed regarding specific pupils, where appropriate

8.4 Reducing persistent and severe absence

Persistent absence is where a pupil misses 10% or more of school, and severe absence is where a pupil misses 50% or more of school. Reducing persistent and severe absence is central to the school's strategy for improving attendance.

The school will:

- Use attendance data to find patterns and trends of persistent and severe absence
- Consider potential safeguarding issues and, where suspected or present, address them in line with Keeping Children Safe in Education
- Hold regular meetings with the parents of pupils who the school (and/or local authority) considers to be vulnerable or at risk of persistent or severe absence, or who are persistently or severely absent, to:
 - Discuss attendance and engagement at school
 - Listen, and understand barriers to attendance
 - Explain the help that is available
 - Explain the potential consequences of, and sanctions for, persistent and severe absence
 - Review any existing actions or interventions
- Provide access to wider support services to remove the barriers to attendance, in conjunction with the local authority, where relevant

- Consider alternative support that could be put in place to remove any barriers to attendance and re-engage these pupils. In doing so, the school will sensitively consider some of the reasons for absence
- Implement sanctions, where necessary (see section 5.2, above)
- Once a child appears on persistent absence we will investigate the reasons, then if these reasons do not meet an exceptional circumstance, parent will receive first stage monitoring letter.

- **Stage 1** – After 3 trending weeks of persistent absence, the parent will be sent a letter outlining the expectations for attendance and the repercussions of being a persistent absentee.
- **Stage 2** – After 6 trending weeks of persistent absence, the parents will be invited to attend a persistent absence panel meeting with the Head of School and Pastoral Lead.
- **Stage 3** – After 9 trending weeks of persistent absence a review will be held for the child’s attendance, during this review our team will make the decision to offer further preventative work or consider further action. If further action is taken, the parents will receive a 15-day monitoring period (3 weeks) in order to improve attendance.
- **Stage 4** – After 12 trending weeks of persistent absence, the attendance will be reviewed, if no improvement is made, attendance will be sent to the local authority for a Penalty Notice Request.

9. Monitoring arrangements

This policy will be reviewed as guidance from the local authority and/or DfE is updated, and as a minimum annually by the Senior Leadership Team. At every review, the policy will be approved by the full governing board.

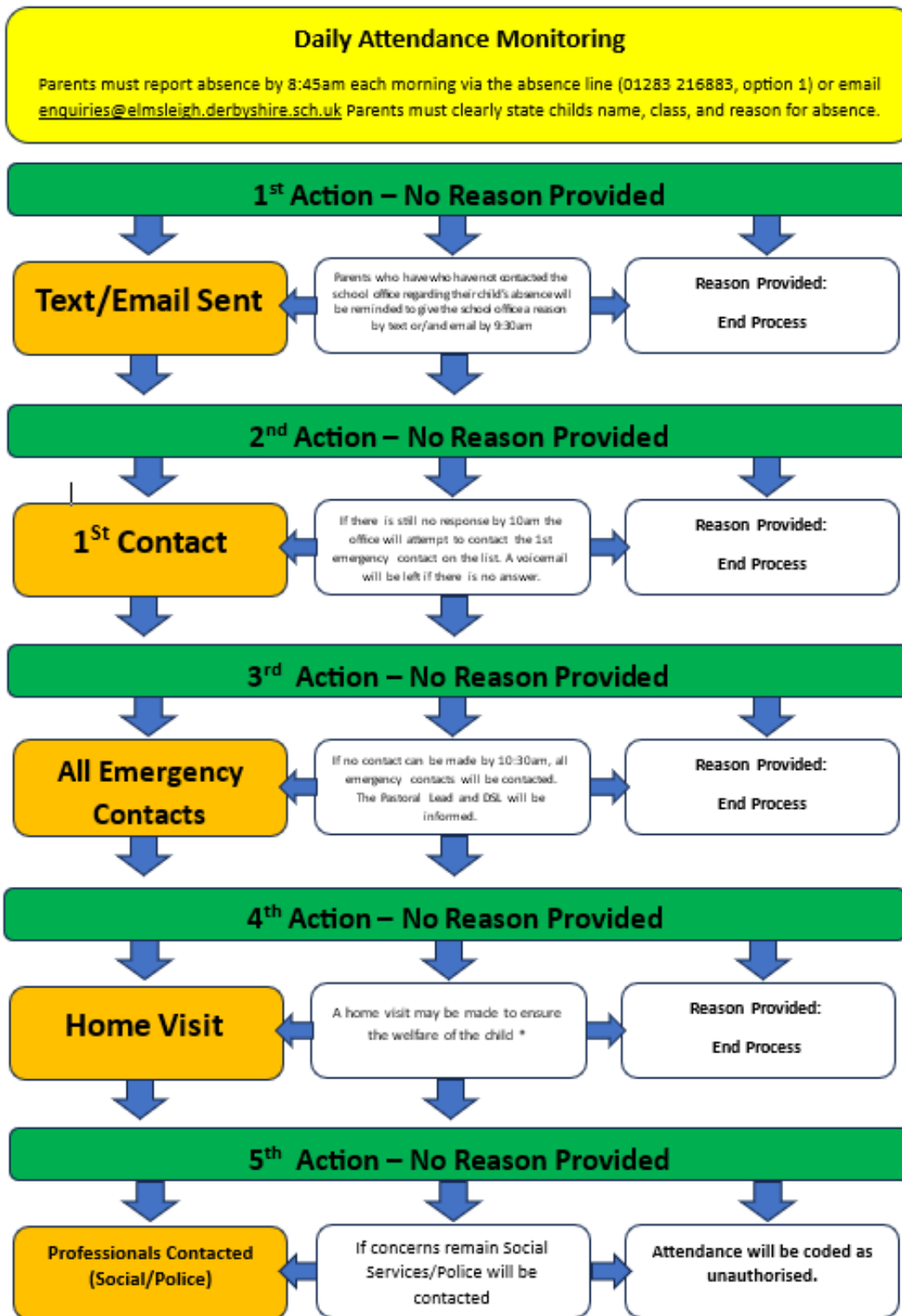
